Implementation Status Overview

The Nigeria State Health Investment Project (NSHIP) was approved by the Board on April 12 2012 and the project is now waiting for the formal signing by the Bank and Government. A critical step to this signing is the legislative approval from the National Assembly. In addition for effectiveness three conditions need to be met (i) development of project implementation manual (PIM) – (ii) at least one subsidiary agreement with a participating state (iii) signing of the HRITF grant agreement which co finances this project. Preparation of the PIM is at an advanced stage.



The Government has been demonstrating strong commitment to the project. All three states (Ondo, Nasarawa and Adamawa) have issued a policy endorsement committing to key institutional and operational reforms. Two of the States have set up the State Primary Health Care Agency which will be the purchasing agency and house the implementation unit at the state level. Similarly project steering committees and the technical working groups have been established at Federal and state levels. In addition, all three states provided finances for the implementation of the ongoing performance based financing (PBF) pre-pilot activities in three LGAs.

The performance based financing (PBF) pre-pilot started in December 2011 and it is ongoing in three (3) Local government areas of Fufore (Adamawa State); Wamba (Nasarawa State); and Ondo East (Ondo State). The pre-pilot is showing immense service quality improvement, improved utilization and increment in values of service delivery indicators.

Critical actions over the remaining part of the year will include (i) establishing the technical assistance for the roll out of the results based financing (ii) completing the baseline surveys to gather valid starting data (iii) planning for the project roll out and delivering on the retroactive financing Disbursement linked indicators.

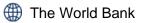
